**MATANUSKA-SUSITNA BOROUGH
ORDINANCE SERIAL NO. 16-041**

AN ORDINANCE OF THE MATANUSKA-SUSITNA BOROUGH ASSEMBLY AMENDING MSB 5.25.012 SERVICE AREA NO. 7: TALKEETNA FLOOD CONTROL SERVICE AREA, TO ESTABLISH THE BOARD OF SUPERVISORS, AND MSB 5.15.010(A), ORGANIZATION OF BOARDS OF SUPERVISORS.

BE IT ENACTED:

Section 1. Classification. This ordinance is of a general and permanent nature and shall become a part of the Borough Code.

Section 2. Amendment of section. MSB 5.25.012 (C) is hereby adopted as follows:

(C) Board of Supervisors. The Talkeetna Flood Control Service Area shall have a board of supervisors consisting of three qualified voters, two (2) of whom who reside within the service area, and one (1) of whom must reside in or own real property in the service area. The board of supervisors shall operate pursuant to MSB 5.15.010. The three-year term shall be calculated on a calendar year basis.

Section 3. Amendment of section. MSB 5.15.010(A) is hereby amended as follows:

(A) Unless otherwise provided [IN THE] by ordinance there shall be a board of supervisors established for each service area and [ESTABLISHING A SERVICE AREA, OR AS PROVIDED BY SUBSEQUENT RESOLUTION OF THE ASSEMBLY,] the board of supervisors for each service area shall be composed of three persons who are qualified voters residing within the service area, appointed by the Mayor and approved by the Assembly. Each supervisor shall serve a term of three years and may serve additional terms. The three-year term shall be calculated on a calendar year basis. The terms of members initially appointed shall be staggered so that as nearly as possible an equal number of vacancies occur each year on a board. Vacancies occurring on a board of supervisors shall be filled for terms remaining by the Mayor, subject to Assembly confirmation.

Section 4. Effective date. This ordinance shall take effect upon adoption.
