RE: Manager's Weekly Post

Late Tax Payments: Tax due dates are set as part of the Budget Ordinance and are typically August 15th and February 15th of each year. If either of these dates fall on a weekend or on a holiday, taxes are due the next business day. For Fiscal Year 2021 Borough Ordinance 20-020 set the due dates as August 17, 2020 and February 16, 2021, with penalties applied on November 16, 2020 (due to COVID this was delayed from August 16th) and February 17, 2021.

Borough Code section 3.15.240 states "A penalty of five percent of the tax due shall be added to all delinquent taxes on the day they become delinquent and every 30 days thereafter." This is done until the taxes are paid or the penalty equals 15%.

All other Borough taxes, except property taxes, must be received by the due date. In the case of property taxes the Borough has accepted a postmark date on or before the due date as timely payment. This is printed directly on the official tax bill and also on the tax payment envelopes. The envelopes state "Mail Early; Avoid Penalties; Payments must be postmarked on or before the due date shown on the official bill."

Twice yearly we have taxpayers who submit payment via mail and their postmark is subsequent to the due date. We keep all envelopes for tax payments received through the end of the August and February to ensure that taxes were postmarked on or prior to the due date are processed as if paid timely. All others are processed as late payments.

Since we are a government and required to treat all taxpayers the same, we cannot remove penalty and interest on one taxpayer without removing it for all taxpayers. We are not able to identify those that were late due to how the postal system date stamps outgoing mail.



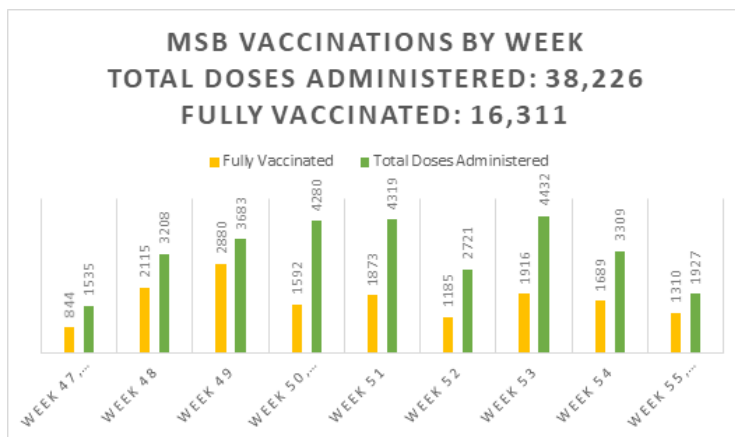
2. Planning Commission (PC): Introduced at 4/19/21 PC meeting; Public hearing/action at 5/3/21 PC meeting.

<p>Project Descriptions</p> <p>MSB residents approved 10 road bond projects in 2018. MSB nominated the projects for federal funding through the Community Transportation Program (CTP). Four of the projects scored high enough to warrant funding through the CTP. The four funded projects are underway with DOT and MSB working together on project scope and right-of-way issues. Three of four maintenance agreements are complete and one is underway. Funding agreements will follow and bond sale is expected in fall 2021.</p> <p>Project Scope: Each project will require completion of the design, ROW acquisition, utility relocation, and construction phases.</p> 	●	Seldon Road Extension	\$8.2M	MSB Estimated Share \$4.1M
