4.43.030 COMPOSITION.
 (A) The board shall consist of seven members representing the following interest areas:
 (1) the chairperson of the local road service area advisory board, or if the chairperson is unable to serve, a member of that board;
 (2) one representative from the public transportation industry;
 (3) one representative from the school district representing student transportation;
 (4) one representative from the transportation engineering or transportation construction community;
 (5) one member representing nonmotorized transportation; and
 (6) two members at large.
 (B) No more than two voting board members may reside within the same road service area.
 (C) Four members shall constitute a quorum and a vote of four is necessary for the board to take action.
